



PATRACKING Ltd – TRACKDAY RIDERS DECLARATION AND INDEMNITY

I, the undersigned wish to ride motorcycles organised by Patracking Ltd, on a closed circuit as part of a track riding event ('track day').

I understand and recognise that:

- Motor sport is hazardous and that I am voluntarily exposing myself to risk of damage or loss or personally injury by participating in this track day.
- It is vital that I provide adequate information, using the appropriate section of this form, about any medical condition that I may have, as well as any medication that I am taking, in order that such information can be made available to medical staff in the event of an accident or other emergency.
- Competitive riding and racing is prohibited and that the purpose of the trackday is to allow the participants to improve their skills and learn the handling and braking characteristics of the motorcycles they are using;
- Any insurance carried by Patracking Ltd and/or the Track Day Organiser, in respect of liability which might arise out of the track day will be limited. My own motor, third party and public liability insurance (if any) is unlikely to cover any losses, liabilities or personal injury that I may suffer, cause or cause others to suffer, but such insurance is available from specialist brokers.
- Patracking Ltd will not be scrutineering participant's motorcycles before permitting them on the track, nor has it any control over the level of competence of other participants.
- Patracking Ltd is not a training organisation and experienced track users from the Track Day Organiser will be on hand to give guidance, but it is just that – informal hints and tips.
- Patracking Ltd will give guidance on and where required, enforce the Track Day Organiser's rules and safety standards. It will not otherwise enforce track discipline or safety measures.
- I myself am responsible for the way in which I use the track, ride my motorcycle and for wearing my appropriate protective clothing.
- Patracking Ltd and/or the Track Day Organiser may refuse me access to the track, either if I infringe any of the Track Day Organiser's rules or regulations or the motorcycle which I ride appear dangerous.
- I confirm that the payment I have made to Patracking Ltd for the day is track bike hire charge only, that it does not include any payment for the instruction or supervision and that it is not refundable in any circumstances.

I declare that:

- I am fit and healthy, that I do not suffer from any other medical condition or disability which is likely to affect my normal control of a motorcycle or which make it unsafe for me to ride or otherwise participate in a track day and that my eyesight (with appropriate corrective lenses if required to be worn) is adequate to safely operate a motorcycle on a race track;
- Any motorcycle for which I am responsible and/or which I will be using during the course of the track day is in good and suitable mechanical condition
- I hold a current full driving licence entitling me to use on the public roads in the UK, for a motorcycle of the size and type that I will be using on the track;
- I will not participate in the track day whilst under the influence of alcohol or intoxicating drugs whilst using bikes hired from Patracking Ltd.

I have read and agree with the above declaration and agree that its terms will also apply to my participation in any future Track Bike Hire days organised by Patracking Ltd unless I sign a subsequent declaration, which will then take precedence.
